## A BILL

To direct the Federal Communications Commission to take certain actions to accelerate the Rural Digital Opportunity Fund Phase I auction, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ACCELERATION OF RURAL DIGITAL OPPOR-
- 4 TUNITY FUND PHASE I AUCTION.
- 5 With respect to the Rural Digital Opportunity Fund
- 6 Phase I auction (in this section referred to as the "auc-
- 7 tion") provided for in the Report and Order in the matter
- 8 of Rural Digital Opportunity Fund and Connect America

1	Fund adopted by the Federal Communications Commis-
2	sion (in this section referred to as the "Commission") on
3	January 30, 2020 (FCC 20–5), the Commission shall
4	modify the framework for the auction adopted in such Re-
5	port and Order as follows:
6	(1) The Commission shall begin accepting long-
7	form applications before the auction, not later than
8	the earlier of the date that is 30 days after the date
9	on which the Commission begins accepting short-
10	form applications or July 31, 2020, from such appli-
11	cants as are willing to commit to the schedule de-
12	scribed in paragraph (3)(B) for deployment of net-
13	works capable of providing symmetrical Gigabit per-
14	formance service.
15	(2) If the long-form applications accepted pur-
16	suant to paragraph (1) indicate that, for any census
17	block or census block group identified in the Prelimi-
18	nary List of Eligible Areas released by the Commis-
19	sion on March 17, 2020, there is only 1 qualified ap-
20	plicant willing to commit to provide symmetrical
21	Gigabit performance service pursuant to the sched-
22	ule described in paragraph (3)(B), the Commission
23	shall, not later than the earlier of September 30,
24	2020, or 30 days before the start of the auction—

1	(A) award to such applicant Rural Digital
2	Opportunity Fund Phase I support for such
3	census block or census block group, at 100 per-
4	cent of the reserve price (in this paragraph re-
5	ferred to as the "award");
6	(B) remove such census block or census
7	block group from the auction; and
8	(C) reduce the budget for the auction by
9	75 percent of the amount of the award and re-
10	duce the budget for the Rural Digital Oppor-
11	tunity Fund Phase II auction provided for in
12	such Report and Order by 25 percent of the
13	amount of the award.
14	(3) The Commission shall require an applicant
15	submitting a long-form application pursuant to para-
16	graph (1) to—
17	(A) not later than 30 days after the date
18	on which such applicant submits such long-form
19	application, provide a letter of commitment
20	from a bank meeting the Commission's eligi-
21	bility requirements stating that the bank would
22	provide a letter of credit to such applicant if
23	such applicant becomes a winning bidder and is
24	awarded support; and
25	(B) commit to—

1	(i) begin construction not later than 6						
2	months following funding authorization;						
3	and						
4	(ii) begin to make service available not						
5	later than 1 year following funding author-						
6	ization.						
7	(4) If an applicant to which an award of sup-						
8	port has been made under paragraph (2)(A) for a						
9	census block or census block group fails to meet the						
10	requirements of paragraph (3) with respect to such						
11	award of support, the Commission shall revoke such						
12	award of support and include such census block or						
13	census block group for competitive bidding in the						
14	Rural Digital Opportunity Fund Phase II auction						
15	provided for in such Report and Order.						
16	(5) The Commission shall require an applicant						
17	to which an award of support has been made under						
18	paragraph (2)(A) to meet the deployment schedule						
19	to which the applicant committed under paragraph						
20	(3)(B).						
21	SEC. 2. ENSURING THE FCC CREATES ACCURATE SERVICE
